#### If you are travelling by car:

If traveling from the north on I-55:

From your route on I-55 South, use the right two lanes to take exit 107 for Madison Avenue toward Colony Park Boulevard. Turn right on Colony Park Boulevard then turn left onto Highland Colony Parkway. Turn left onto Concourse Boulevard to arrive at 1052 Highland Colony Parkway. Guest parking is in the front of the building with an overflow parking lot at the rear of the building.

If traveling from the south on I-55

From your route on I-55 North, take exit 105-B toward Ridgeland. Keep right at the fork and follow signs for Frontage Road. Continue onto East Frontage Road. Use the middle lane to turn left onto Steed Road and take a slight right onto Highland Colony Parkway. Turn right onto Concourse Boulevard to arrive at 1052 Highland Colony Parkway. Guest parking is in the front of the building with an overflow parking lot at the rear of the building.

#### If you are travelling by air:

The Jackson-Medgar Wiley Evers International airport ("JAN") serves the greater Jackson, Mississippi area. The airport is located at 100 International Drive, Jackson, Mississippi, 39208. Air passengers may use charter transportation services, including bus, limousine or taxi services, which are largely offered curbside daily from the first flight departure to the last flight arrival. The airport's rental car counter is hosted in Terminal 1. Please be sure to check for any air or ground transportation service restrictions or terms prior to your planned air travel. #### If you are travelling by rail:

<sup>1</sup> The Company is actively monitoring the public health and travel concerns relating to COVID-19 and the related recommendations and protocols issued by federal, state and local governments.
